**REPUBLIC OF KOREA PRESIDENTIAL UNIT CITATION.**—The *Republic of Korea Presidential Unit Citation* which was awarded by the Republic of Korea to the following units of the United States Army is confirmed in accordance with AR 220-315:

**REPUBLIC OF KOREA PRESIDENTIAL UNIT CITATION** awarded by citation dated 18 September 1954, by Syngman Rhee, President of the Republic of Korea, for exceptionally meritorious service to the Republic of Korea during the period 5 May to 9 July 1953, inclusive, with citation as follows:

The 25th Division gallantly and courageously defended the Munsan-Ni Changdan-Samichon sector against an overwhelming and numerically superior Chinese Communist force. During the period 27 to 28 May, outposts Vegas, Carson, Elko and Berlin, salients of the Division sector, were subjected to heavy artillery and mortar fire by enemy forces, thereby giving indication of an impending large-scale attack. Under cover of heavy fire, the enemy struck these outposts in battalion strength the night of 28 May. They were repulsed and the action was broken off. It was renewed in the early morning hours of 29 May and continued throughout the day, resuming with full fury the night of 29 May, when battalion, regimental, and division strength of the enemy assailed the outposts. Outpost Vegas was hit repeatedly but stubborn and heroic resistance continued. Division forces held outpost Elko in the face of heavy fighting. In the early morning of 30 May elements of the 14th Infantry were thrown into battle to aid and relieve the Turkish forces which held the outposts. Heavy fighting continued during daylight hours around Elko and Vegas and with night the enemy moved forward in a new attack on Carson and Elko. Again elements of the 14th Infantry counter-attacked the Elko-Carson position and secured Elko, holding it under

until withdrawing under  
 together with the Turkish  
 forces on Vegas. During the day of  
 30 May the 14th Infantry completed  
 its relief of the left portion of the  
 Turkish Brigade on the Main Line of  
 Resistance. In this action the enemy  
 secured outposts Carson, Elko, Vegas  
 and Berlin, but only at the greatest  
 cost, and was able to hold them only  
 because the defending forces were  
 withdrawn. The enemy forces failed  
 in their chief objective, which was to  
 breach the Main Line of Resistance  
 at a point where it guarded one of the  
 three main routes of entrance into  
 Seoul.

In their outstanding and heroic  
 performance of duty the men of the  
 25th United States Infantry Division  
 gave freely of their strength, their  
 blood, and their lives. Their conduct  
 was in accord with the highest tradi-  
 tions of the military service.
